Personal Data Processing Agreement

Data Processing Agreement

By signing on to this Agreement and registering his/her personal details with mayakovski-hotel.ru website and all its subdomains and mirror sites (hereinafter referred to as the Website), by filling form fields (registration) the User:

- confirms that all the data provided by him/her belongs to him/her peculiarly;
- acknowledges and agrees that he/she has carefully read the Agreement in full, the text of the Agreement and the processing terms of his/her personal data filled by him/her in the form fields (registration), he/she understands the Agreement text and the personal data processing terms;
- gives consent to processing by the Website the personal data provided as part of the information in order to conclude this Agreement between him/her and the Website, as well as its subsequent execution;
- gives consent to the transfer of his/her personal data to «Lifeline» LLC partners;
- gives consent to receive newsletters about the Website's news, including announcements of articles available on the Website and advertising materials from «Lifeline» LLC partners;
- agrees to the terms of personal data processing.
